Dear Parents and Carers

You will have been aware that the Ofsted inspection team visited school on the 12th and 13th of November. The formal checking process is now complete and we have been advised that we are able to release the report to you. We are absolutely delighted to be able to do so.

The Inspection was carried out under the new framework for inspections that was published 1st September 2013 and so was inspected differently to our last Ofsted Inspection in June 2009. (Since October 2011 the Ofsted framework against which schools are judged has been changed 3 times, each change 'raising the bar'). The new OfSTED inspection framework is tougher and the criteria for judgements much tighter.

The inspection team judged that overall Banks Road Infant and Nursery School is a **good** school.

The report recognises that good teaching was seen across the school during the inspection. All members of staff are committed to strive to consistently good and outstanding teaching. "Teaching is good across the school and this enables all pupils to learn well and make good progress." "The curriculum is interesting and engaging for pupils, and results in good attitudes to learning being shown by pupils".

The inspection team were complimentary regarding the positive attitude of the children at the school. "Pupils have a positive attitude to school, enjoy their lessons and get on well together".

The inspection team recognised that the school's action plan has already identified areas for development which take time to have an impact. In all of the inspectors' comments there was nothing we did not know about and were not already addressing in our plans. "Governors have high aspirations for the school". There is an acknowledgement within the report that major positive changes have taken place in the school following the appointment of the new Head teacher in September 2013."The new headteacher has communicated her vision and high expectations to the staff and governors."

We would like to thank all parents who took the time to complete the survey on Parent View and those parents who spoke to the inspection team. This helped the inspectors to have a good understanding of our school. "Parents have a very positive view of the school".
